Contributors to performance

- → Positioning within high yield industrials
- → Positioning within investment grade financials
- → USD duration positioning

Detractors from performance

- → Positioning within emerging markets

Major changes to portfolio in the period

- → Increased overall credit risk exposure relative to the benchmark, primarily through an increase in emerging markets, the increase was partially offset by a decrease in the high yield exposure.
- → Increased exposure to emerging markets as we are finding select opportunities that offer an attractive risk/reward balance in an environment of elevated uncertainty.
- Decreased exposure to investment grade and high yield financials but remain constructive on bank capital securities given strong balance sheet fundamentals and regulatory support.
